MOTIONS

6. **Need to Restore Orolu State Constituency of Osun State:**
Hon. Adewale Morufu Adebayo:

The House:

Notes that in 2004, the Chairman of the Independent National Electoral Commission (INEC), wrote to the National Assembly requesting approval for the reinstatement of the nation's suppressed state constituencies, including Orolu State Constituency;

Also notes that the residents of Orolu Local Government Area filed a lawsuit in 2013 at the Federal High Court, Osogbo, seeking the restoration of the Orolu State Constituency, citing INEC's inability since 2004 to complete the ward and unit creation required for the Orolu State Constituency election;

Further notes that on 28 May 2014, the Federal High Court ordered INEC to make all necessary arrangements to guarantee Orolu State Constituency would be included in the next General Elections;

Aware that INEC filed an application for leave to appeal the judgement of the Federal High Court, Osogbo at the Court of Appeal, Akure, but failed to pursue the appeal, thereby neglecting the constitutional requirement for proper representation;

Concerned that Osun State, which has nine (9) seats in the House of Representatives, only has 26 members in the State House of Assembly, as opposed to the 27 required under sections 91 and 112 of the Constitution of the Federal Republic of Nigeria, 1999 (as amended);

Disturbed that since 2004, INEC has failed to carry out the necessary ward and polling unit creation to facilitate elections into the restored Orolu State Constituency of Osun State, and that this prolonged delay constitutes a breach of the rule of law, denying the people of Orolu Local Government Area their constitutional right to adequate representation in the Osun State House of Assembly;

Resolves to:

- (i) *urge* the Independent National Electoral Commission (INEC) to comply with the judgment of the Federal High Court in Suit No: FHC/OS/CS/10/2013 by restoring the Orolu State Constituency in accordance with the provisions of Sections 91 and 112 of the 1999 Constitution of the Federal Republic of Nigeria (as amended);
- (ii) *seek* the concurrence of the Senate pursuant to Section 115 of the Constitution of the Federal Republic of Nigeria, 1999 (as amended), for the restoration of the suppressed Orolu State Constituency, Osun State;
- (iii) *mandate* the Committees on Electoral Matters and Legislative Compliance to ensure compliance and report within four (4) weeks for further legislative action.

7. Need to Stop the Constant Rejection of National Youth Service Corps Members by Government Offices in Nigeria:

Hon. Rodney Ebikebina Ambaiowei:

The House:

Notes that the National Youth Service Corps (NYSC) scheme was established as part of the post-civil war reconstruction of Nigeria with the specific aims of fostering national unity, reconciliation, and reconstruction by engaging young graduates in community service and promoting a sense of shared national identity and purpose. The scheme came into effect vide Decree No. 24 of 1973 (now the National Youth Service Corps Act, Cap. N84, LFN, 2004) promulgated by the General Yakubu Gowon administration;

Also notes that since its inception, the scheme has fostered national cohesion and healing, as a mandatory national scheme, graduates of universities and polytechnics from different regions of the country converge to render compulsory one-year national service in locations other than their states of origin and residence

Aware that the scheme has recorded positive impacts in credible service delivery, marriages contracted during service year, successful business development in places of primary assignment, and integration of corps members in their host communities, among other benefits;

Concerned that the scheme, which is designed to provide willing workforce to the public and private sectors, is currently facing setbacks as Government establishments are rejecting NYSC corps members, denying them service opportunities and experience. This has left many graduates vulnerable to exploitation by private firms and crime, while wasting the scheme's intended workforce for public and private sectors.

Disturbed that the rejecting corps members wastes public funds since the government still pays stipends for no economic contribution, without a clear engagement plan, the NYSC scheme loses value and discourages future graduates from participating;

Convinced that proper deployment and utilisation of this young Corps Members' energy in government offices during service year will enhance valuable experience, prepare them for rewarding careers in the public and private sectors, and boost national productivity and economic growth;

Resolves to:

- (i) urge Ministries, Departments and Agencies of Government, including the National Assembly, to desist from rejecting corps members and instead develop work schedules to accommodate them and integrate them into the economic value chain;
- (ii) mandate the Committee on Youth Development to liaise with the Director-General of the National Youth Service Corps (NYSC) to develop a framework for engaging corps members and effectively harnessing their potential during the service year;

**8. Need to Clear Blocked Waterways and Sewages in the Federal Capital Territory, Abuja
Hon. Onuh Onyeche Blessing:**

The House:

Notes the importance of taking care of our sewages and waterway system is essential for preventing hazardous backups;

Also notes that blocked waterways and sewage systems have caused persistent flooding along major roads, particularly Shehu Shagari Way, LaSalle Junction, and Alvan Ikoku Way at Minister Hill, including the Area Councils in FCT. These problems stem from poor drainage maintenance and blocked channels resulting in stagnant water that emits foul odors and poses serious health and environmental hazards to residents and commuters;

Worried that the resulting unhygienic conditions from stagnant water and blocked drains increases the risk of waterborne diseases and affect the quality of life within the FCT;

Also worried that despite repeated public complaints, the response from relevant authorities has remained inadequate, with insufficient proactive measures;

Resolves to:

- (i) urge the Federal Capital Territory Administration (FCTA) and the Ministry of Works and Housing to urgently clear blocked drains and repair drainage systems along Shehu Shagari Way, LaSalle Junction, Alvan Ikoku Way, and other blocked and prone areas in Abuja;
- (ii) also urge the Federal Capital Territory Administration to implement a comprehensive sewage evacuation and drainage maintenance plan and also the FCTA to engage urban planning and environmental experts to develop long-term strategies for preventing block sewages in FCT and affected areas;
- (iii) mandate Committee on Federal Capital Territory and Legislative Compliance to monitor and ensure compliance
